

Terms and Conditions

Champaign County Forest Preserves' Trails Challenge

ELIGIBILITY

1. This challenge is open to all ages, but participants must download the Goosechase app on a smartphone to participate in the Trails Challenge.
2. Champaign County Forest Preserves employees and their immediate family members may participate and earn stickers but are not eligible to win the participation drawings.
3. Participants are expected to act respectfully while participating in the Trails Challenge. Inappropriate usernames or mission photo submissions may result in disqualification and removal from the challenge.
4. Participants must follow all state and federal laws and Champaign County Forest Preserves Ordinances while participating in the Trails Challenge. Forest Preserves Ordinances can be found at [Rules and Regulations](#)
5. The Forest Preserves reserves the right at any time to change Trails Challenge rules and missions. Any changes will be published.
6. Participants must provide a valid email address when registering for the challenge. Champaign County Forest Preserves will not share participant email addresses with other entities.

THE CHALLENGE

1. Participants must download the Goosechase mobile app (iOS / Android), log in or create a free account, and join the Trails Challenge Experience (**CPSRBE**).
2. Participants must complete check-in, photo, or trivia missions in order to qualify for two types of prizes: Gift Baskets, Gift Certificates and Sticker Set.

PRIZES

1. Participants who complete at least one mission during a given time period will be entered in a random drawing to win a prize basket or gift certificate. Time periods and drawing dates will be provided on the website as the date approaches.
2. Prize winners will be notified via the Goosechase app. If a winner does not claim their prize within 30 days from the drawing, the Forest Preserves reserves the right to select a different winner.
3. Prize basket winners will need to arrange pick up of their prize at either Forest Preserves Headquarters, 109 N Lake of the Woods Rd, Mahomet, IL or Museum of the

Grand Prairie, 950 N. Lombard, Mahomet, IL or Interpretive Center of Middle Fork River, 3485 County Road 2700E, Penfield, IL.

4. Participants who reach at least 500 points will be eligible to receive the sticker pack prize. Only one sticker pack can be earned per username. The participant will need to show the front desk staff their Goosechase point total on their device, provide their Goosechase username, and then provide their name for photo credits.

5. Participants that complete the entire challenge will receive a free Trails Challenge t-shirt. Notification to pick up your shirt will be sent through Goosechase app.
